Lingkar Trans Kota Holdings Berhad ("LITRAK Holdings" or "the Company") wishes to announce that the Company has on 1 April 2010 entered into Sale of Shares Agreements with Sistem Penyuraian Trafik KL Barat Holdings Sdn Bhd and Kesas Holdings Bhd to acquire the balance of shares in ETC Links Sdn Bhd (ETC Links) not already owned by the Company totalling 400,002 ordinary shares of RM1.00 each and representing 66.67% of the issued and paid-up capital of ETC Link, for a total cash consideration of RM260,344.46 ("the Acquisition"). The purchase consideration was derived at based on the net assets of ETC Link. Upon the Acquisition, ETC Links became a wholly-owned subsidiary of the Company.

The Acquisition is not expected to have any material effect on the net assets and earnings of the Company and the Group for the financial year ending 31 March 2011.

The highest percentage ratio under paragraph 10.02(g) of the Main Market Listing Requirements of Bursa Malaysia applicable to the Acquisition is 0.06% based on the Company's audited financial statement for financial year ended 31 March 2009.
